HUD Preferred Sustainability Status

The Southeast Florida Regional Partnership's (Partnership) successful application for a HUD Sustainable Communities Regional Planning Grant has also given our seven-county region "Preferred Sustainability Status."

What does the Preferred Sustainability Status (PSS) allow the Partnership to do?

It lets the **South Florida Regional Planning Council** certify applications that are for specific HUD competitive programs. These applications must be consistent with federal livability principles and the Partnership's Regional Vision and Blueprint for Economic Prosperity objectives articulated in the work plan.

Which programs are eligible to receive bonus points?

Additional federal programs, particularly those related to the U.S. Department of Transportation (DOT) and the Environmental Protection Agency (EPA), U.S. HUD's interagency partners, may be eligible for PSS points depending on the program.

What does Preferred Sustainability Status mean for the region's seven counties?

Preferred Sustainability Status is significant for our region. It clearly indicates that HUD is supportive of the work that is being undertaken in Southeast Florida. Additionally, communities from our region will be given bonus points when submitting competitive applications, which will likely increase chances for funding and ultimately contribute to a more livable region.

How does my application get certified for consistency?

1. A short description of your project. If you have an executive summary of the proposal, that would be helpful. Please be sure to include a statement explaining how the project relates to the livability principles and furthers the goals

articulated in the Regional Vision and Blueprint for Economic Prosperity Workplan.

Upon review, Isabel will need to be able to certify the following:

(1) The applicant is engaged in activities, that in consultation with the designated Point of Contact of the HUD designated Preferred Sustainability Status Communities, further the purposes of the regional planning grant program;

(2) The applicant's proposed activities either directly reflect the Livability Principles cited and contained in HUD's General Section to the FY2011 NOFAs or will result in the delivery of services that are consistent with the goals of the Livability Principles;

(3) The applicant has committed to maintain an on-going relationship with the HUD Preferred Sustainability Status Communities for the purposes of being part of the planning and implementation processes in the designated area.
