AGREEMENT FOR PROFESSIONAL SERVICES

THIS IS A CONSULTING AGREEMENT dated June, 2012 by and between
CITISTATES GROUP (hereinafter referred to as "CONSULTANT"), and the INSTITUTE FOR
COMMUNITY COLLABORATION, (hereinafter referred to as TCC), and is made and
entered into this day of May, 2012.
ARTICLE
COMPENSATION
1.1 The ICC agrees to employ the CONSULTANT for the dates and times hereinafter
referred to, in order to perform the Scope of Services as contained in Exhibit "A", which is
attached hereto and incorporated herein by reference. The CONSULTANT's performance of
obligations under this Agreement shall be consistent with applicable, professional and ethical
requirements imposed upon the ICC, existing Rules, or existing agreements as they may be
amended from time to time.
The ICC agrees to pay and to compensate the CONSULTANT consistent with the
terms, conditions and provisions set forth on Exhibit "A", attached hereto and made a specific
part hereof.
ARTICLE II
TERM AND CANCELLATION

2.1 This Agreement shall commence on the June _____, 2012, and shall terminate upon completion of final deliverable, on or before February 24, 2014. Total compensation as may be earned and payable to the CONSULTANT in accordance with **Exhibit "B"**.

ARTICLE III

GENERAL PROVISIONS

3.1	It is understood and agreed that this document incorporates and includes all prior
negotiations,	correspondence, conversations, agreements or understandings applicable to the
	ined herein and that the parties agree that there are no commitments, agreements, or
understanding	gs concerning the subject matter of this Agreement that are not contained in this
document. A	accordingly, it is agreed that no deviation from the terms hereof shall be predicated
upon any pric	or representations or agreements whether orallor written.

- 3.2 It is further agreed that no modification amendment or alteration of the terms or conditions contained herein shall be effective unless contained in a written document executed with the same formality and with equal dignity herewith.
- 3.3 This Agreement is executed and is to be performed in the State of Florida, and shall be governed by and construed in accordance with the laws of the State of Florida.




EXHIBIT "B" METHOD OF COMPENSATION

Compensation for Services

The Consultant shall be paid as follows:

- \$7,000.00 (Seven thousand) for Opening Summit Keynote Address and initial Op Ed, to be paid upon completion of this first task.

 \$2,500 (Two thousand five hundred) for of the three Op Ed's following each of the Seven50 Summits.

Travel expenses for the Consultant to attend Summits shall be reimbursed at cost.
