SEVEN50: SOUTHEAST FLORIDA PROSPERITY PLAN

The Southeast Florida Regional Partnership, in association with the South Florida and Treasure Coast Regional Planning Councils and more than 200 regional partners, is proceeding with the creation of Seven50, Southeast Florida's Prosperity Plan.

The Partnership is developing Seven50, a seven-county, 50-year Southeast Florida Prosperity Plan that will reflect regional agreement around priority investments in key areas of importance to Southeast Florida's future. When considered together, these issues will coalesce into a coherent strategy and investment plan in support of the future sustainability and economic prosperity of our communities and region.

The Council is working to develop Seven50 by the contract completion date of February 21, 2014. A few accomplishments to date include:

A) Work Group Road Show Update

During the July meeting, the Executive Committee approved the Seven50 Work Group Road Show: an intense public input process consisting of seven half-day meetings in each of the seven counties. The Road Show was envisioned as a tool to allow for expanded participation at the local level, as well as an opportunity for each of the Counties to vet the input and priorities outlined during the Opening Summit.

Work Group Road Show Undertakings and Accomplishments:

- Extensive participation and public input: Over 700 people participated in the road show. A summary of the input gathered during each of the meetings is available online at http://seven50.org/seven50-work-group-road-show-recap/.
- Population of the Work Groups: As Seven50 moves into a project development phase, a core group of individuals representing each work group is anticipated to assist the team in the creation and review of the plan. This core group will be led by one or more representatives of the Executive Committee (as appointed by Mrs. Carla Coleman, formerly chair of the Organization and Equity Subcommittee), Consortium members as appropriate, and members of the public/ These members of the public, interested in remaining engaged through the entire planning process and committing to the specific work groups were identified during the road

show. Others, including different Agency experts, will be appointed by the Executive Committee or the Project Director as needed.

- Polling: Polling efforts initiated prior to the first Summit continued during the road show. This information will serve to inform the creation of Seven50.
- Public Input: Extensive, public, local input was gathered during the seven-day event.
- Ample News Coverage: News coverage of the event included articles in the Hometown News, Stuart News, Palm Beach Post, Miami's Community Newspaper; radio coverage on WLYF-FM (South Florida Spotlight) and WMFL 88.5 FM, and T.V. coverage on PBS WPBT Scheduled. Editorials with the Sun Sentinel and the Palm Beach Post as well as an interview with the South Florida Business Journal are scheduled for the upcoming weeks.
- A virtual meeting to recap each of the work groups is anticipated for early 2013 in accordance with the format previously approved by the Executive Committee (Attached).

B) The Executive Committee:

The last Executive Committee meeting was held on Friday, November 30th, at the offices of the Broward Metropolitan Planning Organization. The meeting addressed: (1) proposed appointments; (2) the adoption of the 2013 Executive Committee meeting schedule; (3) an update on undertakings and accomplishments of the Work Group Road Show; (4) the proposed strategy leading up to the Second Summit; (5) a presentation on the Southeast Florida Passenger Rail Coordination Framework; (6) discussion on the terminology of "equity;" (7) a financial and (8) partnership updates on the Seven50 project. The next Executive Committee meeting will be on Friday, March 1, 2013, at the offices of the Broward Metropolitan Organization.

February 1, 2013 (Location & Time to be determined)




