SUBJECT: LOCAL GOVERNMENT COMPREHENSIVE PLAN PROPOSED AND ADOPTED

AMENDMENT CONSENT AGENDA

Pursuant to Section 163.3184, Florida Statutes, Council review of amendments to local government comprehensive plans is limited to 1) adverse effects on regional resources and facilities identified in the *Strategic Regional Policy Plan for South Florida (SRPP)* and 2) extrajurisdictional impacts that would be inconsistent with the comprehensive plan of any affected local government within the Region.

A written report containing an evaluation of these impacts, pursuant to Section 163.3184, Florida Statutes, is to be provided to the local government and the State Land Planning Agency within 30 calendar days of receipt of the amendment.

Staff analysis confirms that the proposed and/or adopted amendments identified in the Table below are generally consistent with and supportive of the Goals and Policies of the *SRPP*. Pursuant to Section 163.3184, Florida Statutes, Council review of amendments to local government comprehensive plans is limited to adverse effects on regional resources and facilities identified in the Strategic Regional Policy Plan for South Florida (SRPP) and extrajurisdictional impacts that would be inconsistent with the comprehensive plan of any affected local government within the region. A written report containing an evaluation of these impacts, pursuant to Section 163.3184, Florida Statutes, is to be provided to the local government and the state land planning agency within 30 calendar days of receipt of the amendment.

DESCRIPTION OF AMENDMENT

The proposed amendment package contains two (2) text amendments to the Broward County Land Use Plan (BCLUP), two (2) changes to the Planning Council Natural Resource Map Series (PCNRM), and one (1) text amendment to the Broward County Comprehensive Plan (BCCP).

BCLUP | Text Amendment PCT 12-2

The text changes would revise Policies within the "Parks and Open Space Use" section to include a new definition for "public access"; incorporate new signage requirements for community parks; limit and restrict future waterway/water body acreage eligible to be counted as a community or regional park unless it has safe public access; and restrict private golf courses from being eligible to count towards park requirements. The Broward County Board of County Commissioners (BOCC) approved the transmittal of the proposed text changes by a 7-1 vote.

PCNRM | Map Update PCNRM 12-1

The Eastern Broward County Wetlands Map would incorporate changes per new observations or permits over the past year. The Broward County BOCC approved the transmittal of the map update by a 7-0 vote.

Climate Change amendments | BCLUP Text PCT 12-3, BCCP Text 12-T1, and PCNRM Map 12-3

The climate change related amendments would implement the recommendations of the Broward County Climate Action Plan, developed by the Broward County Climate Change Task Force and approved by the County Commission on May 4, 2010. The amendments also address the recommendations of the County's 2011 Evaluation and Appraisal Report, which identified climate change as a major issue.

The text changes to the BCLUP would incorporate new Objective A.03.00 and related Policies within the "Smart Growth, Green/Energy Efficiency, and Sustainable Land Use Patterns" section by directing the County to implement and encourage land use planning strategies which increase community resiliency, and protect property, infrastructure, cultural and natural resources from the impacts of climate change. Other BCLUP text revisions would discourage future development at risk of flooding from sea level rise; continue efforts to develop water resource modeling and planning; update the 100-year stormwater elevation projections to include projected conditions for sea level rise; consider impacts of climate change

when making future infrastructure investments and with regards to future coastal management and development.

The text changes to the BCCP would incorporate a new Element to be known as the "Climate Change Element". The Element's Goal and eight (8) Objectives would provide a framework aimed to achieve a sustainable, climate resilient community by promoting and encouraging: energy efficiency and greenhouse gas reduction strategies; the protection and adaptation of public infrastructure, services, natural systems and resources; and coordination to address the needs and conditions of the community. The Policies would set benchmarks for reducing greenhouse gas emissions and increased use of renewable energy sources; include mitigation, protection and adaptation strategies related to transportation, the built environment, natural systems, water infrastructure, and emergency management; promote collaboration between the County, public, and local, regional, state, national and international agency on climate change issues; and incorporate social, public health, education and economic considerations into long-term planning strategies. The Element's data and analysis section would include a: definitions section, greenhouse gas emissions inventory, vulnerability assessment, including inundation mapping, potential impacts, and implementation mechanisms.

The proposed PCRNM map amendment would incorporate a new map to be known as "Priority Planning Areas for Sea Level Rise". The map would implement proposed text changes in the BCLUP and BCCP by designating areas that are at increased risk of flooding due to, or exacerbated by, sea level rise over the next 50 years. The map would identify areas near tidal water body at increased risk of inundation under a 2-foot seal level rise scenario, projected to occur as soon as 2060. This planning horizon is consistent with the Southeast Florida Climate Change Compact's regional Unified Sea Level Projection. The related proposed Policies would discourage density increases and encourage adaptation and mitigation strategies be applied to the priority areas.

The Broward County BOCC approved the transmittal of the climate change proposed BCLUP text amendment by a 7-1 vote; BCCP text amendment by an 8-1 vote; and the PCNRM map addition by a 6-1 vote.

Comment

The Council commends Broward County's efforts to create guidelines that are intended to increase climate resiliency. Council staff served on the Broward County Climate Change Advisory Task Force. Community resiliency is a focus of the Comprehensive Economic Development Strategies, which is in the latter stages of review and approval, and the Seven50 Southeast Florida Prosperity Plan, which is scheduled to conclude in 2014. The Council is prepared to continue to assist Broward County as requested.

DESCRIPTION OF AMENDMENT

The adopted amendment package contains five (5) map amendments and one (1) text amendment to the City of Doral Comprehensive Development Master Plan.

1. Doral Corporate Park | Map and Text Change

A Future Land Use Map (FLUM) change on approximately 13.62 acres of land from Office/Residential to Downtown Mixed Use located on the southwest corner of NW 87th Avenue and NW 36th Street. The amendment includes a Future Land Use Element text change that extends the Urban Central Business District overlay to include the subject property. The City of Doral Council approved the adopted amendment by a 5-0 vote on June 27, 2012.

2. Atrium | Map and Text Change

A FLUM change on approximately 9.82 acres of land from Office/Residential to Downtown Mixed Use located on the northwest corner of Doral Boulevard (NW 36th Street) and NW 79th Avenue. The amendment includes a Future Land Use Element text change that extends the Urban Central Business District overlay to include the subject property and approximately 15 additional acres located between NW 41st Street, NW 79th Avenue, NW 36th Street, and theoretical NW 83rd Avenue. The City of Doral Council approved the adopted amendment by a 5-0 vote on June 27, 2012.

3. Downtown Mixed Use Land Use Category | Text Change

A text change to the Downtown Mixed Use Land Use Category within the Future Land Uses Element that allows a building height bonus for projects that exhibit design excellence, subject to City Council approval. The amendment does not grant new development or intensity rights. The City of Doral Council approved the adopted amendment by a 5-0 vote on June 27, 2012.

4. Federal Reserve Bank | Map Change

A FLUM change on approximately 28.26 acres of land from Institutional and Public Facility to Office/Residential located at 9100 NW 36th Street. The City of Doral Council approved the adopted amendment by a 5-0 vote on June 27, 2012.

5. NW 58th Street Strip Area | Map Change

A FLUM change on approximately 21.0 acres of land from Medium Density Residential to Business located on the south side of NW 58th Street between NW 97th and NW 58th Avenues. The City of Doral Council approved the adopted amendment by a 4-1 vote on June 27, 2012.

6. Doral Design District Core | Text and Map Change

A FLUE text change that creates a new land use category, the Doral Design District Core (DDDC). The amendment includes a FLUM change that designates approximately 185.0 acres of land as DDDC, generally bounded on the north by NW 37th Street, south by NW 25th Street, west by NW 82nd Avenue, and east by the Palmetto Expressway. The City of Doral Council approved the adopted amendment by a 5-0 vote on August 22, 2012.

No additional changes were made between transmittal and adoption. No adverse effects to regional resources and facilities or extrajurisdictional impacts would result from the amendment.

Pursuant to Section 163.3184, Florida Statutes, Council review of amendments to local government comprehensive plans is limited to adverse effects on regional resources and facilities identified in the Strategic Regional Policy Plan for South Florida (SRPP) and extrajurisdictional impacts that would be inconsistent with the comprehensive plan of any affected local government within the region. A written report containing an evaluation of these impacts, pursuant to Section 163.3184, Florida Statutes, is to be provided to the local government and the state land planning agency within 30 calendar days of receipt of the amendment.

DESCRIPTION OF AMENDMENT

The proposed amendment contains a map amendment to the Village Future Land Use Map that would change an approximately 0.56-acre parcel from Conservation to Residential Medium. The parcel is adjacent to Overseas Highway near mile marker 77.5, ocean-side, in Islamorada, Village of Islands.

The site is vacant, comprised of disturbed uplands, low quality tropical hammock, beach berm and mangrove fringe along the shoreline. Surrounding existing uses include a single-family residence to the east, and vacant land owned by the Florida Department of Transportation containing hammock, mangroves and disturbed habitats to the west. Future land uses include Residential Medium to the east and Conservation to the west.

The proposed change would allow one (1) market-rate residential dwelling unit or four (4) attached affordable housing dwelling units. No non-residential uses would be permitted. According to the Village staff report, the amendment change would correct a mapping error made during the transition from the Monroe County Plan to the Village Plan in 2001. The parcel was previously designated Residential Medium. The Village staff analysis concludes the proposed amendment would not impact public facilities or natural resources.

Comment

Council staff would like to remind the Village that the limited potential for additional development throughout the Florida Keys, combined with the existence of a large number of potentially buildable lots, without a plan in place to acquire the excess development rights, means that increases in density or intensity should only be granted in limited circumstances in order to achieve a specific purpose related to other Goals or Policies of the Village Plan. Although the proposed amendment is to correct a mapping error, the amendment has the potential to increase hurricane evacuation clearance times and demands in services.
