SUSTAINABLE COMMUNITIES INITIATIVE

The Southeast Florida Regional Partnership, a collaboration of the South Florida and Treasure Coast Regional Planning Councils and over 200 regional partners and supporters, is proceeding with organizational and program activities necessary to implement the work program. This Project is funded by a grant from the Sustainable Communities Program administered by the U.S. Department of Housing and Urban Development (HUD) in cooperation with the U.S. Environmental Protection Agency and the U.S. Department of Transportation (see www.sustainablecommunities.gov).

Program work is currently being conducted by the staffs of the two Regional Planning Councils, guided by an Executive Committee that has created two Subcommittees: 1) Organization and Equity and 2) Operations. Attachment A is the Partnership's Organizational Chart.

We are also being assisted by a significant amount of in-kind work from numerous members of the Partnership, including staff from public agencies, business professional groups, not for profits and key interested individuals.

2. Palm Beach County Six Pillars – Congratulations to our regional partners in Palm Beach County that have pulled together to work on their "Six Pillars" Initiative. In February 2011, the Economic Council of Palm Beach County launched the "Six Pillars" Initiative to help develop and implement a vision and strategic goals for Palm Beach County as part of the statewide Six Pillars Initiative of the Florida Chamber Foundation. Following years of collaboration and more than a \$1 million in research by the Florida Chamber Foundation, "Six Pillars" or economic drivers have been identified as critical factors to guide Florida's future economy, which is expected to add 5-7 million people by 2030. The Six Pillars are: (1) Talent Supply and Education, (2) Innovation and Economic

Development, (3) Infrastructure and Growth Leadership, (4) Business Climate and Competitiveness, (5) Civic and Governance Systems and (6) Quality of Life and Quality Places. The Six Pillars Initiative is a qualitative research program to develop the first statewide strategic plan to help guide Florida toward a future economy that includes high-wage jobs, global competitiveness and vibrant communities. On August 31, 2011, members of the Palm Beach community came together for a final workshop session to further refine their strategic priorities, goals, and strategies. The Palm Beach County vision and goals, including strategies, tactics and metrics, will be rolled out to the community in October. Their vision and plan will inform and help shape the development of the Regional Vision and Blueprint for Economic Prosperity. This week, the Economic Council reported on the status of its efforts at the Florida Chamber's Future of Florida Summit in Orlando. Their work was very well received.


