SUBJECT: ISLAMORADA, VILLAGE OF ISLANDS, ADOPTED COMPREHENSIVE PLAN

AMENDMENT DCA #10-2

### Community Profile

Islamorada, Village of Islands, is often referred to as the "Sport Fishing Capital of the World" and has over 2,000 registered recreational boats. Located in the Florida Keys, it was incorporated in 1997. The Village had an estimated population of 7,144 in 2010, and a land area of 4,552 acres (7.1 square miles), with a population density of approximately 1,001 people per square mile. The Village population resides primarily on Plantation and Upper and Lower Matecumbe Keys. Although only 55% built out, most of the Village's vacant land has been designated Conservation, limiting any future, large-scale development. Like the rest of Monroe County, Islamorada is dealing with the issues of human impacts on the environment, affordable housing supply, hurricane evacuation, and the loss of the working waterfront. The general location of the Village is shown in Attachment 1.

#### Amendment Review

The South Florida Regional Planning Council (SFRPC) review of proposed Comprehensive Plan amendments for consistency with the *Strategic Regional Policy Plan for South Florida (SRPP)* primarily addresses the effects on regional resources or facilities identified in the *SRPP* and extrajurisdictional impacts that would be inconsistent with the Comprehensive Plan of the affected local government (§163.3184(5), Fla. Stat.). The Council's review of amendments is conducted in two stages: (1) proposed or transmittal and (2) adoption. Council staff reviews the contents of the amendment package once the Department of Community Affairs certifies its completeness.

Objections and Comments relate to specific inconsistencies with relevant portions of the *SRPP*, which was adopted pursuant to Rule 29J-2.009, Fla. Administrative Code. Council staff will work with local governments to address Objections and Comments identified during the review of a proposed amendment between the transmittal and the adoption of the amendment.

#### **Staff Analysis**

The Islamorada, Village of Islands, adopted amendment package #10-2 includes text amendments to the Future Land Use and Coastal Management Elements and one (1) Future Land Use Map change (visit <a href="http://www.sfrpc.com/council/Agenda%20SEP%2010\_6b.pdf">http://www.sfrpc.com/council/Agenda%20SEP%2010\_6b.pdf</a> for map depictions).

The proposed amendment was reviewed at the September 13, 2010 Council meeting and found to be generally consistent with the *SRPP*, with the exception of a Village-sponsored text amendment to the Future Land Use Element related to its potential to compromise the Village's efforts to avoid overdevelopment in the Florida Keys in order to protect Natural Resources of Regional Significance.

A summary of the adopted amendments are presented in the table below.

The amendment package was adopted as proposed with minor revisions. The Village clarified Policy 1-3.1.4 in County Ordinance 10-17 to reflect the amount of development on the sender site or "receiver site" will be limited to the permitted density on the site at the time of the transfer. In addition, the Village updated its Recreation, Open Space, Shoreline Access, and Recreational Resources Inventory. Staff analysis confirms the text changes and the FLUM change is generally consistent with the *SRPP*.

The Islamorada, Village of Islands, Council approved the adopted amendments at its November 18, 2010 meeting.

## Recommendation of Consistency with Strategic Regional Policy Plan (SRPP)

Find the Islamorada, Village of Islands, adopted amendment package #10-2 generally consistent with the *Strategic Regional Policy Plan for South Florida*. Approve this staff report for transmittal to the Florida Department of Community Affairs.
