AUDIT FIRM SELECTION/NEGOTIATION UNDER RFP #0211011-AU

The South Florida Regional Planning Council received responses for the above Request for Proposal (RFP) from four Certified Public Accounting firms.

Staff determined that none of the respondents is on the State of Florida's list of convicted or suspended vendors. Additionally, inquiries with the Florida Department of Business and Professional Regulation have determined that each firm had no probable cause or action found.

After reviewing and evaluating the proposals received, the Selection/Negotiation Committee shortlisted, per the Council approved RFP, the proposals to three firms. Staff is forwarding the three firms selected for consideration by the Executive Committee (see attached). These firms, in alphabetical order, are Alberni Caballero & Company, L.L.P, Harvey, Covington & Thomas, LLC and Sharpton, Brunson & Thomas LLC. These firms have been notified and scheduled for an interview at the June 6, 2011 Executive Committee meeting beginning at 9:00 a.m. The Executive Committee will make a recommendation to the Board at the June 6, 2011 meeting, as to the firm selected for contract negotiation.
