25. POLICE AND FIRE PROTECTION



Fire protection and Emergency Medical Services within the City of Hialeah shall be adequate to provide an effective level of life safety and property protection in all new and proposed developments. A finding that reasonable fire protection and emergency medical service is available shall be based on sufficient water supply, fire protective systems, a proposed development's concurrence with the Florida Fire Prevention Code, and the current system wide capacity to provide timely effective services.

The scope of the Beacon Countyline DRI development has been reviewed and with the knowledge that stringent development guidelines as outlined above will be required of the development, the Hialeah Fire Department can assure an adequate level of Fire Protection and Emergency Medical Services now and into the future. This is based on the current configuration of the Department and future plans to meet additional demands of both commercial and residential development within the Hialeah Heights neighborhood.

The Hialeah Fire Department is a traditional Fire Department that has evolved to be an all hazards emergency service provider. Although the Hialeah Fire Department continues to fulfill it's principal function of fire suppression, emergency medical service, fire prevention and public safety education, it has also taken on the role of hazardous materials mitigation, weapons of mass destruction response, city-wide emergency management coordination and telecommunications.
