Our office received and reviewed the above referenced survey report in accordance with Chapters 267 and 380.06, *Florida Statutes*, for assessment of possible adverse impact to cultural resources (any prehistoric or historic district, site, building, structure, or object) listed, or eligible for listing, in the National Register of Historic Places (NRHP) or otherwise of historical, architectural, or archaeological value.

In August 2007, the Archaeological and Historical Conservancy, Inc. (AHC) conducted an archaeological and historical reconnaissance level survey of the Beacon Countyline parcel on behalf of The Curtis Group. AHC identified no cultural resources within the project area during the investigation.
