Thank you for your letter requesting police service information regarding the MainStreet at Coconut Creek Development of Regional Impact (DRI). Please be advised that police service in the general area of the proposed project is adequate at this time. However, significant growth in residential and commercial development within this area will result in increased demands for police service. The demands for service typically vary, based upon the specific demographics of an area and traffic volumes. Further, service demands normally are evaluated, once neighborhoods and commercial zones are established, and reevaluated on an on-going basis, utilizing the annual budgetary process.

A preliminary review of the MainStreet at Coconut Creek DRI project indicates that the potential impact on the city's police department resources could be considerable, based upon the significant increase in residential and mixed-use commercial development. This large-scale, regional development will also greatly increase traffic volume. As the project is phased over the build out period, additional sworn personnel resources will be required to maintain the current level of service to the area. As part of the review process, the applicant will be expected to mitigate for such impacts.
