

#### Comments

Information contained in the application states that the Development of Regional Impact (DRI) boundary for the approximately 70-acre site is generally located at Broward Boulevard, between I-95 and SW 27th Avenue. The application indicates no existing/permitted units for the site. Therefore, the project was reviewed for 427 mid-rise units, and as proposed, is anticipated to generate an additional 20 (12 elementary, 5 middle, and 3 high school) students into Broward County Public Schools.

This application was reviewed based on its location in the School District's Long Range Seven Planning Areas, and Ten Year Long Range Plan contained in the Adopted District Educational Facilities Plan (DEFP). However, the statistical data regarding the level of service standard (LOS) status of the actual schools impacted by this DRI application in the initial five-year of the ten-year period is depicted herein for informational purposes only.

Schools serving the site in the 2008/09 school year are North Fork and Riverland Elementary, Arthur Ashe and New River Middle, and Dillard and Stranahan High Schools. Based on the District's Public School Concurrency Planning Document, each of these schools are operating below the adopted LOS of 110% permanent capacity in the 2008/09 school year.

Incorporating the cumulative students anticipated from approved and vested developments anticipated to be built within the next three years (2008/09 - 2010/11), these schools are expected to operate below the adopted LOS of 110% through the 2010/11 school year. It should be noted that the permanent school capacity or Florida Inventory of School Housing (FISH) for the impacted schools reflects compliance with the class size constitutional amendment and the permanent capacity additions that are planned for the Schools within the first three years of the Five-Year Adopted District Educational Facilities Plan (DEFP) FY 2008/09 – 2012/13. Also, to ensure maximum utilization of the impacted Concurrency Service Areas, the Board may utilize other options such as school boundary changes to accommodate students generated from developments in the County. Additionally in the 2008/09 school year, Charter Schools located within a two-mile radius of the site are depicted above. Students returning, attending or anticipated to attend charter schools are factored into the five-year student enrollment projections for District schools. Enrollment projections are adjusted for all elementary, middle and high schools impacted by a charter school until the charter school reaches full enrollment status.

Capital Improvements scheduled in the currently Adopted District Educational Facilities Plan (DEFP), Fiscal Years 2008/09 to 2017/18 regarding pertinent impacted schools are depicted above.

Based on the School District's Seven Planning Areas, the amendment site is located within School District Planning Area E and the elementary, middle and high schools currently serving Planning Area E and their cumulative twentieth day student enrollment, permanent capacity and ten-year student enrollment projections are depicted herein.

Planning Area E has an excess elementary school cumulative permanent capacity of 2,691, excess middle school cumulative permanent capacity of 1,694, and excess high school cumulative permanent capacity of 3,048. The long range capital facilities plan indicates that the funding for the construction of a replacement building for North Fork Elementary School is slated for FY 2013-14.


Therefore, Planning Area E is anticipated to have sufficient excess capacity to support the students generated by the proposed development. As such, this application is not anticipated to have a negative impact on Broward County Public Schools.
