SUBJECT: HURRICANE WILMA BRIDGE LOAN LITIGATION STATUS REPORT

The South Florida Regional Planning Council administers the Hurricane Wilma Emergency Bridge Loan program on behalf of the State of Florida Governor's Office of Tourism, Trade and Economic Development (OTTED). The Emergency Bridge Loan Program was a short term business loan program that helped small businesses in Miami-Dade, Broward and Monroe counties bridge the gap between the time the hurricane hit and when the business could secure other resources such as sufficient profits from revived business, receipt of payments on insurance claims, and secured longer-term loans.

The loan approval process consisted of a team of bankers that reviewed and approved the loan applications for each county and forwarded them to the Council for administering. The combined total number of loans approved by the committees was 399.

The current bridge loan account status report and litigation report from Goren, Cherof, Doody and Ezrol are attached for your review and include borrowers that are making payments as a result of the litigation actions.

Below please find the status of the Hurricane Wilma Loan cases which have been brought on behalf of the SFRPC.

**I - SETTLEMENT IN PROCESS**

**1. SFRPC (Account #7136/\$25,000.) v. Top Katch Seafood, Inc. and Albert M. Adams (File #70233)**

Joint Stipulation forwarded to Mark Berkley, Esquire, attorney for the Defendants. Defendants will make monthly payments in the amount of \$1,000.00 commencing on April 1, 2008. Received executed Joint Stipulation on March 11, 2008. Agreed Order Approving Settlement entered March 25, 2008. Payment received on 4/1/08 in the amount of \$1,000. sent to client on 4/14/08.

**2. SFRPC (Account #6182/\$10,000.) v. Renaissance Medical and Lydia Arvelo, 15870 NW 10<sup>th</sup> Street, Pembroke Pines, FL 33028 (File #70017)**

SFRPC received Mr. Bakar's March payment on March 5, 2008. April payment due.

Defendants must be served by December 18, 2007. Defendants served October 12, 2007. Defendants answer due November 1, 2007. Clerk Defaults filed December 11, 2007. Settlement negotiations in process pursuant to correspondence of January 3, 2008 received from Thomas M. David, Esquire counsel for the Defendants. Joint Stipulation forwarded to Mr. David for execution. Defendants are to make \$1,866.66 monthly payments commencing February 15, 2008. SFRPC received Ms. Harmon's February payment on February 19, 2008. March payment due.
