COMMUNITY NEEDS ASSESSMENT

Executive Summary

The survey analyzed in this report was conducted by volunteers from the Broward County Human Services Department and from the local community. The Grants Management, Research and Evaluation Division of the Human Services Department designed the survey questionnaire (see Appendix 1), and also coordinated and supervised the administration of the surveys. The survey results were analyzed and reported by the Center for Urban Redevelopment and Empowerment at Florida Atlantic University (FAU-CURE).

The surveys were administered face-to-face in the zip codes listed below over a two-week period in late July and early August, 1999. A total of 11 zip codes were involved in the survey. The zip codes are 33004, 33009, 33020, 33023, 33060, 33069, 33311, 33312, 33313, 33314 and 33441. These zip codes are categorized into three regions within the county, as follows:

North Broward County, consisting of zip codes 33060, 33069 and 33441

Central Broward County, consisting of zip codes 33311, 33312 and 33313

South Broward County, consisting of zip codes 33004, 33009, 33020, 33023 and 33314

Based on the population of the zip codes selected for the survey, Grants Management selected a total sample of 1,100 residents to be surveyed. Overall, 1,052 responses were received, resulting in a response rate of 95.6%. The analysis in this report shows the responses to the survey questions by zip code and by region. The analysis enables a comparison of the responses within and between zip codes, and within and between regions. All percentages (%) were calculated on the basis of the number of respondents (n) to each question in each zip code and in each region. It is important to note that the survey conducted was "self-reporting", meaning that the information collected or documented was relayed by the respondents. The information is conveyed directly, and without any interpretation, in this report.

The socio-economic and educational profiles of the neighborhoods surveyed are quite noteworthy. Racially, the profile of the neighborhoods surveyed shows that majority of the residents are African Americans. Low-income people of other racial or ethnic groups also live in the neighborhoods. Tables 1 and 2 respectively show the racial and gender breakdowns of the survey respondents by zip code. Table 2 shows that the rate of female respondents doubles the

rate of male respondents. Table 1 further shows that between all the zip codes:

- 1. The highest concentration of Black respondents is in zip code 33069, which is in the North County, followed by zip code 33311in the Central County, and zip code 33023 in the South County.
- 2. Zip code 33314 in the South County has the highest concentration of Whites, followed by zip code 33441 in the North County, and zip code 33312 in the Central County.
- 3. Zip code 33009 in the South County has the highest concentration of Hispanics, followed by zip code 33020, also in the South County, and zip code 33312 in the Central County.
- 4. Zip code 33313 in the Central County has the highest concentration of Haitians, followed by zip code 33009 in the South County, and 33060 in the North County.

Table 3 shows the age groups of the survey respondents by zip code. The Table further shows that between all the zip codes:

- 1. Zip code 33313 in the Central County has the highest percentage of young adults, ages 18 to 24 years, followed by zip code 33009 in the South County, and by zip codes 33060 and 33069 in the North County.
- 2. Zip code 33311 in the Central County has the highest percentage of middle age residents, ages 25 to 44 years, followed by zip code 33313 also in the Central County, and zip code 33314 in the South County. The highest concentration of middle age residents in the North County is very close to that in zip code 33314 in the South.
- 3. The three highest percentages of seniors, age 60 years and older, are all in the South County. Zip code 33313 in the Central County has the lowest percentage of seniors. In the Central County, zip code 33312 has the highest percentage of seniors, while in the North County, zip codes 33069 and 33441 are tied for having the highest percentage of seniors.

Table 5 shows the number of children under 18 years living with the survey respondents. Further, the Table shows that of all the zip codes:

1. 33069 and 33060 in the North County respectively reported the highest numbers of children (5 or more) living with the survey respondents, followed by zip code 33004 in the

South.

2. The lowest number of children reported was in zip code 33004, followed by 33009 and 33020, all in the South County.

The survey respondents were asked about how much they like their neighborhoods. Table 6 shows that overall, residents of zip code 33069 in the North County strongly like their neighborhood the most, followed by zip code 33023 in the South County and zip code 33060 in the North County. Conversely, residents of zip code 33313 in the Central County strongly dislike their neighborhood the most, followed by zip code 33060 in the North County (where respondents also indicated a strong liking for their neighborhood) and 33020 in the South County.

Asked about the duration of their residency in their neighborhoods, the responses summarized in Table 8 show that overall, zip code 33069 in the North County has the most residents who have lived in the neighborhood for over 5 years, followed by zip code 33023 in the South County and zip code 33060, also in the North County. The shortest duration of residency is in zip code 33020 in the South County, followed by zip code 33313 in the Central County and zip code 33314 in the South County.

Housing is a key indicator of neighborhood quality. Tables 9 - 13 show various aspects of housing in the neighborhoods. Specifically, Table 9 shows how the respondents rate the condition of housing in their neighborhoods. Overall, the highest rating of housing was in zip code 33020 in the South County, followed by zip code 33060 in the North County, tied with zip codes 33004 and 33314, both in the South County, and lastly zip code 33009, also in the South County. The lowest rating was in zip code 33069 in the North County, followed by zip code 33313 in the Central County and zip code 33060 in the North County.

Table 12 provides some insights into homeownership rates in the neighborhoods surveyed. Overall, the homeownership rate is highest in zip code 33060 in the North County, followed by zip code 33023 in the South County and zip code 33069 in the North County. The rate is lowest in zip code 33441 in the North County, followed by zip code 33313 in the Central County and zip code 33020 in the South County. In the same vein, it was discovered that rental rate is highest in zip code 33441 in the North County, followed by zip code 33313 in the Central County, and zip code 33004 in the South County. The rate is lowest in zip code 33060 in the North County, followed by zip code 33023 in the South County, and zip code 33069 in the North County.

Still on housing, Table 13 lists the problems that the survey respondents reported having with their dwelling units, both rental and owned. The most and least common problems reported by

zip code are as follows.

- 1. In zip code 33004, broken windows and damaged doors were the most and least common problems reported, respectively.
- 2. In zip codes 33009, 33020, 33023, 33314, 33060 and 33441, they were plumbing problems and boarded windows.
- 3. In zip code 33311, they were broken windows and boarded windows.
- 4. In zip code 33312, they were broken windows, followed by plumbing, and no other problem.
- 5. In zip code 33313, only broken windows were reported, and no other problems.
- 6. In zip code 33069, they were damaged roofs, tied with damaged doors, and boarded windows.

As shown in item 2 above, the most and least commonly reported housing problems were plumbing and boarded windows.

The economic profile of the neighborhoods surveyed shows in Table 79 that the percentage of respondents who reported being currently employed was highest in zip code 33060 in the North County, followed by zip codes 33311 and 33023 in the Central and South Counties, respectively. The percentage reporting being unemployed was highest in zip codes 33004, 33069 and 33020 in the South, North and South Counties, respectively. Furthermore, Table 82 shows that the highest percentage of respondents who reported working less than full time or seeking full time employment is highest in zip codes 33313 and 33312, both in the Central County, followed by zip code 33060 in the North County. In terms of household income, Table 84 shows that the percentage of respondents who reported having a household income of \$40,000 or more per year was highest in zip code 33314 in the South County, followed by zip codes 33060 and 33009 in the North and South Counties, respectively. On the other hand, the percentage of those reporting household incomes of below \$10,000 per annum was highest in zip code 33069 in the North County, followed by zip codes 33009 and 33004, both in the South County.

Inquiries about the educational attainments of the survey respondents show in Table 92 that the percentage of respondents who reported having a college degree or higher is highest in zip codes 33314 and 33020, both in the South County, followed by zip code 33311 in the Central

County. On the other hand, the percentage of those reporting having less than 9th grade was highest in zip codes 33023 and 33311 in the South and Central Counties (tied), followed by zip codes 33312 and 33069 in the Central and North Counties (tied), and by zip code 33009 in the South County.

Several questions in the survey inquired about the levels of access that respondents have to various services in their neighborhoods. Some examples of the services probed are as follows. Responses to inquiries about child care are summarized in Tables 19 - 22. Taking Table 19 for instance, the survey respondents reported that:

- 1. Overall, licensed child care is most available in zip code 33314 in the South County, followed by zip code 33060 in the North County, and zip code 33313 in the Central County.
- 2. Licensed child care is least available in zip code 33020 in the South County, 33060 in the North County, and zip code 33313 in the Central County.
- 3. Licensed child care is least needed in zip code 33009 in the South County, followed by zip code 33004 also in the South County, and zip code 33312 in the Central County.

Respondents to the survey were specifically asked about the convenience of day care facilities to their homes or places of work. Table 21 shows that:

- 1. Day care facilities were most convenient to the homes or workplaces of residents of zip code 33069 in the North County, followed by zip codes 33023 and 33313 in the South and Central Counties, respectively.
- 2. Day care facilities were least conveniently located for residents of zip code 33060 in the North County, followed by zip codes 33311 and 33312, both in the Central County.

Table 23 shows that survey respondents in zip code 33313 in the Central County reported having the most difficulty in finding afterschool programs, followed by respondents in zip codes 33311 and 33023 in the Central and South Counties, respectively.

Tables 85 - 91 show the various types of public assistance programs, such as food stamps and SSI, received by the survey respondents. Noteworthy is Table 85, which shows that the percentage of respondents who reported receiving basic assistance is highest in zip code 33069 in the North County, followed by zip codes 33020 and 33313 in the South and Central Counties, respectively.

It was important to inquire if the survey respondents know where to go to access or get a range of services, including social services, health services, job training, housing purchase assistance, and so on. Tables 57- 62 summarized the responses to the questions asked. Table 57 shows, for example, that the highest level of "unawareness" about where to go for social services was reported in zip code 33313 in the Central County, followed by zip codes 33069 and 33023 in the North and South Counties, respectively. In the same vein, Table 61 shows that the highest level of "unawareness" about where to go for help in buying a first home was reported in zip codes 33023, 33020 and 33004, all in the South County. Finally, Table 62 shows that, six months before the survey, the incidence of people who applied for any service and had to be wait listed was highest in zip code 33004 in the South County, followed by zip codes 33060 and 33311 in the North and Central Counties, respectively.

The survey inquired about access to medical insurance. Table 63 lists the types of medical insurance reported by the survey respondents. Noteworthy in the Table is that the percentage of the uninsured is highest in zip code 33020 in the South County, followed by zip codes 33313 and 33312, both in the Central County. Within the regions, the percentage is highest in zip codes 33060, 33313 and 33020 in the North, Central and South Counties, respectively.

One important area that the survey probed was the overall physical and mental health of the respondents. Table 66, for example, shows how the survey respondents described their general health condition. The highest percentage of those reporting to be in excellent health was in zip code 33312 in the Central County, followed by zip codes 33020 and 33441 in the South and North Counties, respectively. The highest percentage reporting to be in poor health was in zip code 33309, followed by zip codes 33023 and 33004, all in the South County.

Respondents were asked if their health has limited their ability to work. Table 69 shows that the highest percentage of respondents who indicated that their health has limited their ability to work was in zip codes 33009 and 33020, both in the North County, followed by zip code 33069 in the North County.

Table 71 shows that the percentage of survey respondents who indicated having sought treatment in the past six months for substance abuse was highest in zip codes 33009 and 33312 in the South and Central Counties (tied), followed by zip codes 33004 and 33313 in the South and Central Counties, respectively.

Tables 73 - 78 show the responses to the questions about the mental conditions and moods of the survey respondents. For example, Table 74 shows that the number of respondents who reported suffering from anxiety was highest in zip codes 33311, 33313 and 33312, all in the

Central County. Table 76 shows that the figures for those suffering from depression are highest in zip code 33009 in the South County, followed by zip codes 33020 and 33060 in the South and North Counties (tied), and zip code 33023 in the South County.

The survey respondents were asked to estimate their levels of concern about various issues in their neighborhoods, ranging from the physical aspect to quality-of-life issues. The responses are summarized in Tables 26 - 56. Examples of such concerns are as follows.

- 1. Table 26 shows that the level of concern about housing is "highest" in zip code 33069 in the North County, followed by zip codes 33060 and 33313 in the North and Central Counties, respectively. Conversely, the level of concern is "lowest" in zip codes 33004, 33020 and 33314, all in the South County.
- 2. Table 29 shows that the level of concern about literacy classes is "highest" zip code 33069 in the North County, followed by zip codes 33023 and 33060 in the South and North Counties, respectively. Conversely, the level of concern is "lowest" in zip codes 33004, 33314 and 33020, all in the South County.
- 3. Table 30 shows that the level of concern about GED classes is "highest" in zip code 33069 in the North County, followed by zip codes 33023 and 33060 in the South and North Counties, respectively. Conversely, the level of concern is "lowest" in zip codes 33004, 33314 and 33020, all in the South County.
- 4. Table 31 shows that the level of concern about job training is "highest" zip code 33069 in the North County, followed by zip codes 33023 and 33313 in the South and Central Counties, respectively. Conversely, the level of concern is "lowest" in zip codes 33004 and 33020 in the South Counties, followed by zip code 33312 in the Central County.
- 5. Table 32 shows that the level of concern about unemployment is "highest" in zip code 33023 in the South County, followed by zip codes 33069 and 33313 in the North and Central Counties, respectively. Conversely, the level of concern is "lowest" in zip codes 33004, 33314 and 33020, all in the South County.
- 6. Table 36 shows that the level of concern about school quality is "highest" zip codes 33314 and 33441 in the South and North Counties (tied), followed by zip codes 33023 and 33060 in the South and North Counties, respectively. Conversely, the level of concern is "lowest" in zip codes 33004 and 33020, both in the South County, followed by zip code

33312 in the Central County.

- 7. Table 38 shows that the level of concern about gang activity is "highest" in zip codes 33313 and 33060 in the Central and North Counties (tied), followed by zip codes 33023 and 33069 in the South and North Counties, respectively. Conversely, the level of concern is "lowest" in zip codes 33004, 33441 and 33312, respectively in the South, North and Central Counties.
- 8. Table 39 shows that the level of concern about school dropouts is "highest" zip code 33060 in the North County, followed by zip codes 33023 and 33069 in the South and North Counties, respectively. Conversely, the level of concern is "lowest" in zip codes 33004 and 33020, both in the South County, followed by zip code 33441in the North County.
- 9. Table 47 shows that the level of concern about domestic violence is "highest" in zip codes 33060 and 33069, both in the North County, followed by zip code 33023 in the South County. Conversely, the level of concern is "lowest" in zip codes 33004 and 33020, both in the South County, followed by zip code 33312 in the Central County.
- 1. Table 42 shows that the level of concern about primary health care is "highest" in zip codes 33060 and 33069, both in the North County, followed by zip code 33023 in the South County. Conversely, the level of concern is "lowest" in zip codes 33004 and 33020, both in the South County, followed by zip code 33312 in the Central County.
- 2. Table 46 shows that the level of concern about crime is "highest" zip codes 33060, 33069 and 33441, all in the North County. Conversely, the level of concern is "lowest" in zip codes 33004 and 33020, both in the South County, followed by zip code 33313 in the Central County. Within the regions, the level is highest and lowest in zip codes 33314 and 33004 in the South County, zip code 33313 for both rates in the Central County, and zip codes 33060 and 33441 in the North County.
- 10. Table 48 shows that the level of concern about child abuse is "highest" in zip codes 33069 and 33060, both in the North County, followed by zip code 33023 in the South County. Conversely, the level of concern is "lowest" in zip code 33004 in the South County, followed by zip codes 33312 and 33314 in the Central and South Counties, respectively.
- 11. Table 51 shows that the level of concern about child care is "highest" in zip codes 33060 and 33069, both in the North County, followed by zip code 33023 in the South County. Conversely, the level of concern is "lowest" in zip codes 33004 and 33314, both in the South County, followed by zip code 33312 in the Central County.

- 12. Table 53 shows that the level of concern about elderly services is "highest" in zip code 33060 in the North County, followed by zip codes 33023 and 33069 in the South and North Counties, respectively. Conversely, the level of concern is "lowest" in zip codes 33004 and 33020, both in the South County, followed by zip code 33313 in the Central County.
- 13. Table 55 shows that the level of concern about teenage pregnancy is "highest" in zip code 33023 in the South County, followed by zip codes 33060 and 33069, both in the North County. Conversely, the level of concern is "lowest" in zip codes 33314 and 33004, both in the South County, followed by zip code 33312 in the Central County.
- 14. Table 56 shows that the level of concern about HIV/AIDS is "highest" in zip codes 33060 and 33069, both in the North County, followed by zip code 33023 in the South County. Conversely, the level of concern is "lowest" in zip codes 33004 and 33020, both in the South County, followed by zip code 33312 in the Central County.

Finally, the survey asked respondents to assess how social service agencies respond to the various needs or concerns identified in their neighborhoods and summarized in Tables 26 - 56. Tables 93 - 122 show the mixed assessment of the performance of social services in addressing neighborhood needs and concerns.

Zip codes 33004 and 33314 in the South County recorded the lowest numbers of adults (1 to 2) living with the survey respondents, followed by zip code 33441 in the North County.

Tables 6 and 7 provide some insights into how residents feel about their neighborhoods. Judging from Table 6, for example:

- 1. In the South County, residents of zip code 33023 like their neighborhood the most, while residents of zip code 33020 like theirs the least.
- 2. In the Central County, residents of zip code 33312 like their neighborhood the most, while residents of zip code 33313 like theirs the least.
- 3. In the North County, residents of zip code 33069 like their neighborhood the most, while residents of zip code 33060 like theirs the least.
- 4. Overall, residents of zip code 33069 in the North County like their neighborhood the most, followed by zip code 33023 in the South County and zip code 33060 in the North County.

Conversely, residents of zip code 33313 in the Central County dislike their neighborhood the most, followed by zip code 33060 in the North County and 33020 in the South County.

The duration of the residency of the respondents in their neighborhoods is summarized in Table 8. From this Table:

- 1. Residents of zip code 33023 have resided in the South County the longest (over 5 years), versus residents of 33020 (less than one year). In the Central County, the zip codes are 33311 versus 33313. In the North County, they are 33069 versus 33441.
- 2. Overall, zip code 33069 in the North County has the most residents who have lived in the neighborhood for over 5 years, followed by zip code 33023 in the South County and zip code 33060, also in the North County. The shortest duration of residency is in zip code 33020 in the South County, followed by zip code 33313 in the Central County and zip code 33314 in the South County.

Housing is a key indicator of neighborhood quality. Tables 9 - 13 show various aspects of housing

in the neighborhoods. Specifically, Table 9 shows how the respondents rate the condition of housing in their neighborhoods.

- 1. In the South County, housing was rated as both excellent and poor by residents of zip code 33020.
- 2. In the Central County, residents of zip code 33311 rated housing as excellent, compared to the poor rating by residents of zip code 33313.
- 3. In the North County, residents of zip code 33060 rated housing as excellent, while residents of zip code 33069 rated it as poor.
- 4. Overall, the highest rating of housing was in zip code 33020 in the South County, followed by zip code 33060 in the North County, tied with zip codes 33004 and 33314, both in the South County, and lastly zip code 33009, also in the South County. The lowest rating was in zip code 33069 in the North County, followed by zip code 33313 in the Central County and zip code 33060 in the North County.

Homeownership is a critical element of neighborhood revitalization and stability. Table 12 shows that:

- 1. In the South County, homeownership rates are highest and lowest in zip codes 33023 and 33020, respectively. In the Central County, they are zip codes 33311 and 33313, respectively. In the North County, they are zip codes 33060 and 33441, respectively.
- 2. In the South County, rental rates are highest and lowest in zip codes 33004 and 33023, respectively. In the Central County, they are zip codes 33313 and 33311, respectively. In the North County, they are 33441 and 33060, respectively.
- 3. Overall, the homeownership rate is highest in zip code 33060 in the North County, followed by zip code 33023 in the South County and zip code 33069 in the North County. The rate is lowest in zip code 33441 in the North County, followed by zip code 33313 in the Central County and zip code 33020 in the South County.
- 4. Overall, the rental rate is highest in zip code 33441 in the North County, followed by zip code 33313 in the Central County, and zip code 33004 in the South County. The rate is lowest in zip code 33060 in the North County, followed by zip code 33023 in the South County, and zip code 33069 in the North County.

Table 13 listed the problems that the survey respondents reported having with their dwelling units, both rental and owned. The most and least common problems reported by zip code are as follows.

- 7. In zip code 33004, broken windows and damaged doors were the most and least common problems reported, respectively.
- 8. In zip codes 33009, 33020, 33023, 33314, 33060 and 33441, they were plumbing problems and boarded windows.
- 9. In zip code 33311, they were broken windows and boarded windows.
- 10. In zip code 33312, they were broken windows, followed by plumbing, and no other problem.
- 11. In zip code 33313, only broken windows were reported, and no other problems.
- 12. In zip code 33069, they were damaged roofs, tied with damaged doors, and boarded windows.

As shown in item 2 above, the most and least commonly reported housing problems were plumbing and boarded windows.

- Overall, the usage rate is highest in zip code 33023 in the South County, followed by zip code 33069 in the North County and zip code 33314 in the South County. The lowest rate is in zip code 33313 in the Central County, followed by zip code 33312, also in the Central County, and zip code 33009 in the South County.

Tables 19 - 22 inquired about child care in the neighborhoods surveyed. Table 19, for example, shows that:

- 1. Overall, licensed child care is most available in zip code 33314 in the South County, followed by zip code 33060 in the North County, and zip code 33313 in the Central County.
- 2. Licensed child care is least available in zip code 33020 in the South County, 33060 in the North County, and zip code 33313 in the Central County.
- 3. Licensed child care is least needed in zip code 33009 in the South County, followed by zip code 33004 also in the South County, and zip code 33312 in the Central County.

Respondents to the survey were specifically asked about the convenience of day care facilities to their homes or places of work. Table 21 shows that:
