## I. ASSEMBLY AND ORGANIZATION

- a. The meeting was called to order by Mr. Nathan Kogon at 2:20 P.M.

  - a. Steve Wernick of Bilzin Sumberg Baena Price & Axelrod LLP talked about gaming in Florida and provided a handout. Explained Class III license allows blackjack and betting against the house. Class II license allows players to bet against each other, for example poker. The take rate for existing casinos is 35%, it would be 10% for new destination casinos. Three casino licenses would be available for Miami-Dade and Broward counties. There is a question regarding what infrastructure improvements will be necessary and economic and social issues.
  - b. Ivan Rodriquez stated committee was not meeting for now. Looking at ways/procedures to use charter schools as mitigation and still need to come up with the ways.

A motion to send a letter of support from PTC was made by Rogelio Madan and seconded by Manuel Perez-Vichot. The motion was approved unanimously.
