

RESOLUTION 07-04

A RESOLUTION BY THE STEERING COMMITTEE OF THE STATE ROAD 7/U.S. 441 COLLABORATIVE REQUESTING REPRESENTATION FROM THE MIAMI-DADE COUNTY SCHOOL BOARD TO SERVE AS A STEERING COMMITTEE MEMBER OF THE STATE ROAD 7/U.S. 441 COLLABORATIVE AND TO ASSIST WITH THE DEVELOPMENT OF MITIGATION STRATEGIES AND IDENTIFICATION OF CAPITAL IMPROVEMENTS NEEDED TO ACCOMMODATE THE POTENTIAL IMPACTS UPON SCHOOL FACILITIES.

Whereas, the State Road 7/U.S. 441 Collaborative is partnership of 16 jurisdictions and multiple agencies working to improve conditions along the corridor; and,

Whereas, the Steering Committee of the Collaborative has expressed its desire to create an area-wide comprehensive and functional Master Plan to guide future redevelopment activities along the State Road 7/U.S. 441 Corridor; and,

Whereas, the Steering Committee members wish to collaborate with other area local governments to address current land use, transportation, economic and aesthetic issues along the State Road 7/U.S. 441 Corridor and increase intergovernmental cooperation; and,

Whereas, the Steering Committee includes representation from each corridor jurisdiction; the Broward Metropolitan Planning Organization; the Florida Department of Transportation District IV; Broward County School Board; Broward County Planning Council and the South Florida Regional Planning Council; and,

Whereas, the City of Miami Gardens is a Steering Committee member of the State Road 7/U.S. 441 Collaborative; and,

Whereas, the Miami-Dade Metropolitan Planning Organization and the Broward Metropolitan Planning Organization have conducted joint transportation studies along the State Road 7/U.S. 441 Corridor within Miami-Dade and Broward Counties; and,

Whereas, the Steering Committee seeks input and coordination with Miami-Dade County School Board in development and implementation of the State Road 7 Strategic Master Plan; and,

Whereas, the Steering Committee conducts quarterly meetings to discuss and conduct business; and,

Whereas, the Steering Committee has established a Schools Sub-Committee as part of the State Road 7 Strategic Master Plan process; and,

Whereas, the Miami-Dade School Board provides public school facilities for all jurisdictions in Miami-Dade County; and,

Whereas, the City of Miami Gardens has adopted a Comprehensive Plan that will encourage new residential development along the State Road 7 Corridor; and,

Whereas, the Steering Committee wishes to coordinate with the Miami-Dade School Board and the School Board of Broward County to ensure the adequate provision of public schools with the impacts of the anticipated redevelopment of this corridor.

Now, Therefore, Be It Resolved by the Steering Committee of the State Road 7/U.S. 441 Collaborative that:

- 1. The Miami-Dade School Board consider approval of the State Road 7 Partnership Agreement; and,
- 2. The Miami-Dade School Board consider appointing a representative and alternate of the Board to serve as a member of the Steering Committee of the State Road 7/U.S. 441 Collaborative.
- 3. The Miami-Dade School Board participate in identifying mitigation strategies needed to accommodate projected school impacts.
