II. Implementation Elements (I)

Task I1 - Future Land Use Map Classification:

A. Schedule for Task I1

Begin: July 1, 2003

End: December 31, 2004

B. Scope of Services for Task I2

The Council will:

- By January 30, 2004, create a sub-committee of The State Road 7/U.S. 441 Collaborative to review and provide technical assistance to Broward County to address the development of a corridor-based Mixed-Use Future Land Use Map category.
- 2. Work in partnership with Broward County to submit an amendment to the County's Comprehensive Plan to create a corridor-based Mixed-Use Future Land Use Map category that will support the State Road 7 Master Plan vision and related redevelopment activities.
- By December 31, 2004, create a model amendment package that can be utilized by all corridor communities to amend their respective Comprehensive Plans to incorporate the new Mixed-Use category.
